Recent experience: Defence

He has defended in a number of murders (see notable cases), and has broad experience in all types of serious and allegations of organised crime, including serious fraud, and missing trader fraud. He has particular expertise in cases involving complex medical evidence, particularly those involving the death of children. He has broad experience in sexual offences including rape. He has been instructed to defend in the largest case ever prosecuted by a local authority (regarding alleged fake Government websites).

Recent experience: Prosecution

He has very substantial experience in linked operations, sensitive cases, and paper-heavy allegations. He is regularly instructed on behalf of the CPS Appeals Unit in Judicial Review and Appellate work where he did not appear in the first instance case.

He was instructed to prosecute Tommy Adams in a series of high profile allegation money laundering cases, where many of the defendants were represented by Queen's Counsel. A total of 10 defendants were

convicted. He was instructed on behalf of the Office of Fair Trading in the first ever prosecution of pyramid selling. He acted in one of the largest confiscation cases ever brought by a local authority.

He has conducted cases for the Fraud Prosecution Service, Inland Revenue, Office of Fair Trading, Customs and Excise and Asset Recovery Agency. He has broad experience in confiscation and money laundering proceedings (see notable cases), and mortgage frauds. He has prosecuted cases involving the death of infants. He is a Category 4 prosecution advocate and on the Confiscation Specialist counsel list.

Regulatory, Consumer and Product Liability

Denis was the Editor of the Blackstones Guide to the Consumer Rights Act 2015. It deals with substantial changes to the law between consumer and businesses for goods, digital content, services, and unfair contract terms. The Act consolidates the powers of enforcement officers and amends substantially the Enterprise Act.

In addition Denis' areas of specialisation include Trade Mark, Copyright, Consumer Credit, Product Safety, Planning and Environmental offences, for which he is instructed by both defendants, companies including supermarkets, and local authorities.

He has substantial experience in the maze of European Directives and Regulations creating criminal offences. He was involved in the first appeal involving the Transfrontier Shipment of Waste Regulations (Environmental law): see notable cases.

He has lectured and given seminars at the last 14 Trading Standards annual conferences. He has brought a number of injunctions under Part VIII of the Enterprise Act 2002.

Health Care

Denis has represented Pharmacists and Doctors before the GMC and the GPC, and has been instructed on behalf of Hospital Trusts in complex Inquests.

Competition/Cartels

He was instructed on behalf of a building company in the recent OFT investigation into cover pricing in the building industry, involving written and oral representations to the OFT Tribunal. R v N.A. (BBC News, 7th December 2007): Allegation of murder of 18 month old by father. The defendant was acquitted of murder.

R v Mayfield-Sparks (BBC News, 22nd January 2008): in which the defendant killed his brother in front of his mother with a Samurai sword.

R v Cain (BBC News 2009). Central Criminal Court.

R v A.W. BBC News 2013. Defendant was said to have attacked a man in a joint attack after a party. He was acquitted.

R v Uppal BBC News 2014. Defendant left jurisdiction for 17 years after a large fight between two gangs in Southall.

R v Andrews BBC News 2016. Represented defendant who pleaded guilty to murdering his wife and defrauding his father in law.

Attempted Murder

R v Vinter. Defendant serving a whole life term alleged to have attempted to murder another man serving a whole life sentence.

Manslaughter

R v J.C. BBC News 2014. Alleged manslaughter as a result of restraint by the defendant of a drunk man in a man. He was acquitted. Case prosecuted and co-defended by Queens Counsel.

Cases Involving Infants

R v K.L. Defendant cleared of causing the death of her 23 month old daughter from a head injury.

R v Williams. Prosecution involving section 18 allegation and child cruelty against an infant. Defendant convicted.

R v Lewis. Prosecution involving section 18 allegation and child cruelty against an infant. Defendant convicted.
